## **2020 SWIMMING CARNIVAL**

Event: Kurmond Public School Swimming Carnival. ALL students in Years 3 – 6 are expected to attend the Carnival. **Richmond Swimming Pool** Venue: Tuesday 4th February 2020 Date: 9.15 am - 2.30 pm Time: Bus - leaves school at 9.15 am Travel: Bus - returns to school by 3.00 pm Cost: \$16.00 for bus travellers - covers cost of bus, pool entry and pool hire (to be paid through school prior to carnival) OR

**\$8.00** for car travellers - covers pool entry and pool hire (to be paid through school <u>prior</u> to carnival). *Students must be at the pool by 9.30 am. <u>Parents must be at the pool for return</u> <u>pick up by 2.15 pm</u>.* 

\*Concession tickets cannot be used. Spectator admission fees of \$1 will be charged at the gate.

**Nil cost for students who attended Special Swimming Scheme in November 2019** – <u>NO PAYMENT REQUIRED</u> as two sessions were cancelled due to extreme weather events. This serves as a refund for those days.

- <u>Bring</u>: Hat, sunscreen, sleeved shirt (T-shirts in house colours or sports uniform <u>NO singlet tops</u>), drink bottle, recess, lunch, swimmers, towel, plastic bag for wet clothing
   \* Children will be responsible for applying own sunscreen
- <u>Carnival</u>: 8 12 year old swimmers competitive events and possible house relays (final places based on times no finals)
  - Years 3 6 non-swimmers only shallow-end races, including kickboard races adult support will be available

Parents may pay by cash or cheque or make **online payments** using Visa or MasterCard credit or debit cards. Go to the school website <u>www.kurmond-p.schools.nsw.gov.au</u> and click on 'Make a Payment' where the instructions are clearly explained. After completing the mandatory fields, i.e. those shown with \*, tick the 'Sport' box and enter 'Swimming Carnival'. Return the permission note the next day with the online section completed.

Due to limited organisational time, we would really appreciate if notes and payments can be returned this week but, if not, definitely no later than **Thursday 30<sup>th</sup> January**. Medley swimmers must compete in the individual 50m freestyle, back, breast and butterfly strokes before entering. The 100m freestyle is an open age event. **District representation in all races depends on qualifying times, not places.** 

Students will be sitting in house groups. <u>Parents wishing to sit with their children must sit in the appropriate</u> <u>house areas</u>. Children will <u>not</u> be allowed to sit with parents away from their house groups.

<u>Please note</u>: 8-year-old Year 2 2020 students may only attend if they can competently swim in 50m events and are willing to compete at District Carnival level, if they qualify. <u>There will be NO novelty races or shallow-end races for Yr 2 2020 students</u>. Non-competing Yr 2 2020 students are NOT to attend as spectators, they are to attend school as usual.
